- 1. The guaranteed cash payments will be transferred to pay the premium due of other policies on the *Transfer Day unless the premium has already been paid. If the transfer amount is specified, any excess amount will be transferred to the Future Premium Deposit Account of other policies (A low Interest rate account).


